On June 28, 2018, Public Act 255 was signed, creating a Lions of Michigan Foundation Fund within the Michigan Department of Treasury to assist our foundation in collecting donations to help improve the quality of life of people in our state with unmet needs. This act added the Lions of Michigan Foundation to the list of only nine Michigan Charities eligible to receive donations directly from Michigan tax payers when they file their annual state income tax return. Each qualified charity is required to collect \$50,000 in donations annually

through this special program to guarantee eligibility for the future. We are asking for any help you can provide to ensure we remain eligible. Just a donation of \$5 - \$10 to our foundation, from each Lion member, family or friend

on the Michigan Voluntary Contribution Schedule (MI form 4642), would ensure that we cannot be removed from the list of qualified charities. This would cover many of our programs we donate to including Kid Sight, Individual Assistance Program, helping Veterans with surgical problems and costly medical procedures, including hearing loss, and Emergency Disaster Relief, helping families affected by natural disasters. NOMINATIONS AND ELECTIONS

Lions, Our District needs new leaders to continue the leadership provided to our clubs by our current leadership team. We have received no nominations to date for 2nd Vice District Governor. We also currently do not have a 2nd Vice District Governor in our District. Why is this important? Because the steps to Governor are: 2nd VDG, then 1st VDG, then District Governor. That way, in a normal progression, the District Governor receives two years of training and experience as 2nd VDG and then 1st VDG prior to serving as leader of our district.

What are the qualifications necessary to run for 2nd Vice District Governor, you might ask? Good Question; from our Constitution and Bylaws which any member can find on our website, by clicking the drop down left menu and select INFO, then on the next page, go to column one and click on the 5th item under District Resources: District 11E1 Constitution tab, you will find on page 6...

In order for a Lion to be eligible and qualified to be selected to fill a vacancy in the office of first or second vice district governor, he/she must: (a) Be an Active Member in good standing of a chartered Lions club in good standing in his/her single or sub-district. (b) Have served or will have served at the time he/she takes office as first or second vice district governor: (i) As officer of a Lions club for a full term or major portion thereof; and (ii) As a member of the district cabinet for a full term or major portion thereof the above being accomplished concurrently.

Now, you might ask, what are the responsibilities of the 2nd Vice District Governor? Great Question; again from the Constitution and Bylaws, you will find on page 9...

Section 3. SECOND VICE DISTRICT GOVERNOR. The second vice district governor, subject to the supervision and direction of the district governor, shall be an assistant in the administration of the district, and representative of the district governor. His/her specific responsibilities shall be, but not limited, to: (a) Further the purposes of this association. (b) Perform such administrative duties assigned by the district governor. (c) Perform such other functions and acts required by the International Board of Directors. (d) Participate in the cabinet meetings, and conduct meetings in the absence of the district governor, and first vice district governor, and participate in council meetings as appropriate. (e) Familiarize himself/herself with the health and status of the clubs in the district, review the monthly financial report and assist the district governor and the first vice district governor in identifying and strengthening the existing and potential weak clubs. (f) Conduct club visitation, as the representative of the district governor, when requested by the district governor. (g) Assist the district governor and first vice district governor in planning and conducting the annual district convention. (h) Work with the District LCIF Coordinator and assist the committee to achieve the goals of the year through regular distribution of LCIF information and materials to increase understanding and support of LCIF. (i) Work with the District Information Technology Committee and assist the committee to promote the use of the association's web site and the Internet among the clubs and members to obtain information, file reports, purchase club supplies, etc. (j) At the request of the district governor, supervise other district committees. (k) Assist the district governor, first vice district governor, and the cabinet in planning of the next year, including the district budget. (I) Familiarize himself/herself with the duties of the district governor so that, in the event of a vacancy in the offices of district governor and first vice district governor, he/she would be better prepared to assume the duties and responsibilities of said offices as the acting district governor or acting vice district governor until the vacancies are filled according to these by-laws and rules of procedure adopted by the International Board of Directors.

Now, you may want to know how one goes about being nominated to run for 2nd Vice District Governor; If you proceed to Exhibit F, on Page 22 of the Constitution, you will find a check list to be submitted with the candidate's nomination letter. Nomination letter you ask? Yes, each candidate for District Election must be nominated by their club and voted on at a regular club meeting. (it can be virtual) An example of a proper nomination letter received from our District Governor's club as an

MICHIGAN TAX FORM

The Lions of Michigan Service Foundation worked with state legislators to be placed on the Michigan Tax form charities list. There are nine organizations that you can make a charitable deduction to on the form. However, sometimes it takes patience to find the item on your 1040 or the form that you use. The stipulation with the legislation is that each agency must earn approximately \$50,000 a year from tax filers to stay on the form. All Michigan taxpayers can donate. The Michigan Lions Foundation has been on the charitable list for three years and has earned only about half that amount in any year. A donation can be made by those taxpayers receiving a refund and those owing the Michigan government more taxes. The donation does not have to be large. A five- or - ten -dollar (the price of a Mac and a drink) donation would help. This is an easy way for Lions to help the Foundation complete its mission to the people of Michigan in the form of hearing aids, KidSight screening, eye surgeries and much more. Use the attached form (pg 11 below) when you complete your taxes and encourage your family and friends to do so. A donation can go a long way. The attached form should accompany your taxes.

Dear Lion Leaders,

I hope this correspondence finds each of you healthy and safe during these unprecedented times. This pandemic has stressed our organization, our nation, and the world like no one could have ever imagined. I firmly believe that during difficult times, true leaders shine. I am proud of each of you for not only stepping up to lead the charge, but to lead by example. General Patton once said, "A good plan, violently executed now, is better than a perfect plan next week." The fact of the matter is that we are thinking on our feet and as situations are thrusted upon us. There is no textbook on how to handle the present state of affairs. Therefore, no matter what level of leadership, whether it be at the club level or on the international board, we must think and react swiftly and adapt to change. What aids us in the decision-making process? It's simple, your heart and your passion to serve. We know if we don't continue to do acts of service in our communities, people will be lost and alone in what arguably may be the most difficult points in their lives. The need today may be greater than ever before. Disasters don't stop because of a pandemic. Your community needs you; the world needs you. When we joined our clubs, we were drawn to our motto, "we serve". So, I ask you to continue to lead as you have never done before. Look for new ways to serve our communities, new members to aid us in the charge, and thrive to be the best leader that you can be.

Your International Board of Directors are here to serve by your side. The following are some recent actions taken by your board:

1. <u>Charter and entrance fee waiver through June 30, 2021</u>. Any new club chartered, or any new member sponsored into our organization will be exempt from the standard fee to become a member/club. The board understands at this time, many

people want to serve but are financially strained. We wish to not withhold one's membership for reasons that they did not have control over or had no opportunity to plan. Our hopes are that this will encourage our members to seek out the individuals that share the same passion as you and I and not have them turned away for financial reasons.

2. Flexible Payments through June 30, 2021. Clubs that were in good standing on December 31, 2020, will not be suspended or canceled for nonpayment of dues. The board understands that many of our current members face financial hardships because of the pandemic. Members that have paid dues for 10, 20, 30 years have now struggled to continue their financial obligation because of the pandemic. We are passionate about each one of our over 1.4 million members and understand that each one of those members touches on average the lives of 50 individuals each year.

3. <u>The International Convention has now gone virtual</u>. With the potential tens of thousands of our members that would transcend in Montreal, Quebec, it would not be safe. The board recognizes the value of our members safety and while we realize there is no way to completely allow our members to feel the experience of an international convention, we are offering the next best thing, a virtual convention. This will allow even more individuals to have the convention experience. We will elect our new executive officers as well as new international board members.
